NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, September 28, 2010, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes, to consider:

**GRADING PERMIT & MINOR SITE PLAN REVIEW (CASE NO. ZON2010-00172):** A request to construct a 5,909ft<sup>2</sup> (5,216ft<sup>2</sup> habitable space & 693ft<sup>2</sup> garage) split-level residence with 3,880yd<sup>3</sup> of related grading and install photovoltaic solar panels on a vacant lot.

All interested parties are invited to submit written comments and to attend and give testimony. If you have any comments or concerns about the proposed project, please communicate those thoughts in writing to our staff by Tuesday, September 21, 2010. By doing so, you will ensure that your comments are taken into consideration for the staff analysis of the project. Written comments submitted after Tuesday, September 21, 2010, will be given to the Planning Commission prior to the meeting. Please note that written materials, including emails, submitted to the City are public records and may be posted on the City's website. In addition, City meetings may be televised and may be accessed through the City's website. Accordingly, you may wish to omit personal information from your oral presentation or written materials as it may become part of the public record regarding an item on the agenda.

Only those who have submitted written comments at or prior to, and/or given testimony at the public hearing will receive notification of the decision. The Planning Commission's decision may then be appealed, in writing, to the City Council. The appeal shall set forth the grounds for appeal and any specific action being requested by the appellant. The appeal letter must be filed within fifteen (15) calendar days of the Planning Commission's decision and must be accompanied by a \$2,255.00 appeal fee.

In accordance with the Municipal Code, the applicant may have attempted to contact you prior to submitting an application to inform you of his/her intentions and allow you to view the building plans for this project. If the applicant did not contact you, or you would like the opportunity to review these plans further, they are on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review from 7:30 AM to 5:30 PM Monday through Thursday, and from 7:30 AM to 4:30 PM Friday.

In addition, a temporary frame structure (silhouette) has been constructed on the site to outline the height and bulk of the proposed project. This frame will be in place throughout the duration of the comment period to better assist you and the City to assess any project impacts.
